

RENAULT TEST DRIVE CHALLENGE

SECTION A. General Terms and Conditions

1. The "Renault Test Drive Challenge" ("**Test Drive Contest**") is organized by TC EURO Cars Sdn. Bhd. (Company No. 113605-D) ("TCEC") and is open to all residents in Malaysia aged eighteen (18) years old and above with a valid driving license.
2. Any person who is:
 - (a) the employees of TCEC (including its holding company, subsidiaries and related companies), including their immediate family members;
 - (b) the sales promotion agencies and advertising agencies of TCEC, including their immediate family members,is automatically ineligible for this Test Drive Contest.
3. This Test Drive Contest shall commence from **7th November 2018** at **12.00a.m.** until **31st December 2018** at **11.59 p.m.**(both dates inclusive)("Test Drive Period").
4. TCEC reserves the right to vary, add modify and/or alter these terms and conditions for the Test Drive Contest ("T&C") as and when it deems fit. Such variations may be communicated through modes of communication deemed suitable by TCEC.
5. These T&C shall be governed by and construed in accordance with the laws of Malaysia.
6. By participating in the Test Drive Contest, the participant(s) declares that he/she has read and understood the T&C herein and agree(s) to be bound by the same.

SECTION B. Participation Mechanisms

1. How to participate:
 - a. Participants who are interested to participate in this Test Drive Contest can test drive any Renault models at any Renault showroom during the Test Drive Period. After the test drive, the participants will be required to fill in the test drive entry form ("the Form") in full and answer ONE (1) mandatory question shown in the Form. The participants may then submit the Form to any Renault showroom; or
 - b. Participants who book the Renault Captur model using GoCar app during the Test Drive Period will be automatically qualified in the Test Drive Contest PROVIDED that they answer and reply the mandatory question via Short Message Service ("SMS") upon receipt of the same from TCEC..
2. Upon completion of the test drive, the participants will be given a gift, the gift shall be subject to stock availability.

3. Test drive is subject to vehicles availability and eligibility. Participants will be required to contact the relevant Renault showroom for purposes of making an appointment for the test drive. All test drive must be conducted in the presence of an authorized Renault sales consultant.
4. Each participant is entitled to only one (1) entry for the Test Drive Contest. In the event the participant has multiple entries, only one (1) entry for the Test Drive Contest will be deemed as valid.

SECTION C. Prize(s)

1. The available prizes for the Test Drive Contest are as follows ("Contest Prize(s)"):
 - a. Apple iPhone XS (64GB) x 5 winners
 - b. RM100 petrol gift cards x 50 winners
 - c. Renault gift pack x 30 winners

The winners will be selected by TCEC and each selected winner shall only be entitled to ONE (1) Contest Prize.

2. The decision of TCEC in respect of the Test Drive Contest shall be final and conclusive. No correspondences or appeals shall be entertained.
3. The results for the Test Drive Contest will be announced by TCEC on **31st January 2019** via the Renault website (www.renault.com.my) and TCEC's Facebook at [Facebook.com/RenaultMalaysia](https://www.facebook.com/RenaultMalaysia). The announcement date may be amended by TCEC at any time and at its sole discretion.
4. All costs, charges, fees and/or expenses of whatsoever nature that are associated with the participation in the Test Drive Contest and/or the acceptance of the Contest Prizes shall be at the sole responsibility of participants and/or the winners.
5. The winners will be contacted by phone and/or email based on the information contained in the submitted Form. In the event the winners cannot be contacted and/or does not respond within two (2) business days of the first attempt contact, TCEC reserves its absolute right to select new winner(s) for the relevant Contest Prize. TCEC will not be liable in the event that the eligible winners cannot be contacted for whatever reason.
6. TCEC reserves the right to use any other mode or medium that it deems fit at its sole and absolute discretion for the purpose of announcing the winners, contacting the winners, verifying the identity of the winner and delivering the Contest Prize.
7. The Contest Prizes are accepted entirely at the risk of the winners and the TCEC excludes itself from any express or implied warranties in connection with the Contest Prizes to the maximum extent permitted by law.

8. The Contest Prizes are not transferable, exchangeable or redeemable for cash or any other item. However, TCEC may at any time at its sole and absolute discretion substitute the Contest Prize with other items of an equal or similar value with or without conditions.

TCEC hereby disclaims and shall not be held liable for any claims and liability howsoever arising from personal injuries, medical conditions and damage to property originating from the participants' participation in the Test Drive Contest and/or the winners' acceptance of the Contest Prizes and the participants and/or winners shall hold TCEC harmless from any such claims.

SECTION D. Other Terms and Conditions

1. In the event that the Test Drive Contest cannot be administered due to any reason, TCEC, without being subject to any form of liability and at its sole and absolute discretion, may cancel, terminate, modify, or suspend the Test Drive Contest without assigning any reasons thereto and without notice.
2. Any personal data collected by TCEC from your registration for and/or participation in the Test Drive Contest will be processed in accordance with the Personal Data Protection Act 2010 ("PDPA"). By participating in the Test Drive Contest, the participants hereby consent to TCEC processing his/her personal data according to TCEC's PDPA notice.
3. By participating in this Test Drive Contest, the participants hereby consent to TCEC to use, publish, exhibit and display participant's name, the last four digits of their identification card number/passport number, image and comments in any nature or form for documentation, advertising and promotional purpose in any form of media and any reasonable manner it sees fit without additional compensation. The participants are not eligible to claim any proprietary right thereto.
4. TCEC may at its sole and absolute discretion disqualify any participants and/or revoke the Contest Prize at any time, where:
 - a. The participants fail to comply with these T&C;
 - b. The participants attempt to undermine the operation and administration of the Test Drive Contest by fraud, cheating or deception;
 - c. The participants fail to provide accurate, complete, valid, identifiable and/or truthful information for the registration and/or participation in this Test Drive Contest; or
 - d. The Form submitted by the participant is not completed in full or not legible.
